
Building Next-Generation Policy Expertise

The ReThink.CEE Fellowship of the German Marshall Fund of the United States (GMF) is built on the conviction that a more resilient, democratic, and internationally engaged Central and Eastern Europe is not only possible but essential for the development of a prosperous and integrated Europe. By empowering new voices and channeling regional expertise into European and transatlantic policy debates and networks, the fellowship seeks to strengthen the intellectual foundations of a more cohesive and forward-thinking Europe.

As Central and Eastern Europe faces mounting challenges to democracy, security, and prosperity, the countries of the region and their partners urgently need fresh thinking, ideas, strategies, and policies. The ReThink.CEE Fellowship is designed to generate such policy impulses by tapping the sizeable reservoir of next-generation policy experts, innovators, and thought leaders from the eastern members of the EU to the countries of the Eastern Partnership and the Western Balkans.

During a year-long non-residential fellowship, ReThink.CEE fellows identify, research, and analyze policy challenges in the region, and they develop ideas for responses by regional and international stakeholders. Their results are published by GMF as policy papers. In this way, the ReThink.CEE Fellowship supports the development of regional expertise and amplifies its policy impact internationally.

Besides a stipend and travel and research funds, ReThink.CEE fellows are provided with professional opportunities, intellectual resources, and capacity-building to develop their analytical and policy skills, expertise, and public profile. Support includes workshops on policy research and writing, guidance from GMF peers, cooperation with GMF offices and networks, and assistance with media exposure.

Fellowship Components

GMF's long-standing experience of working with think tanks and civil society organizations in Central and Eastern Europe proves that there is a sizeable reservoir of promising professionals in the region. Their rise and impact, however, is often hampered by limited opportunities and resources, and the lack of supportive local networks that would assist in developing their

skills. The ReThink.CEE Fellowship seeks to fill this gap and to support talented individuals in conducting creative and timely policy research. In doing so, it also strengthens the capacities of the think tank and civil society sectors of the region, and promotes high-quality, evidence-based policy thinking in addressing regional challenges.



The ReThink.CEE Fellowship offers:

Affiliation with a premier transatlantic think tank

For a one-year period, fellows are affiliated with GMF and gain access to its network of policy professionals, programs, and offices. Affiliation with GMF supports fellows in developing their international network and provides them with exposure to European and transatlantic policy debates.

Individual mentoring

Individual mentoring plays a crucial role in the fellowship. Fellows are connected with mentors who provide personalized support and feedback on their individual policy research project and help with its conceptualization and design. This tailored approach creates a collaborative, empowering environment in which fellows can reflect on their work, tackle challenges, and benefit from the expertise of senior professionals in their respective fields.

Community building

A core strength of the fellowship is the exchange among fellows from diverse national backgrounds. This interaction begins at an introductory workshop and is reinforced throughout the fellowship through regular engagement involving the ongoing cohort, ReThink.CEE alumni, and GMF staff. These opportunities for collaboration broaden fellows' perspectives and foster a sense of community.

Alumni engagement

GMF maintains strong ties with ReThink.CEE fellows beyond their fellowship period through a growing alumni network, offering continued opportunities for professional engagement and collaboration, including mentoring new fellows as well as speaking and publication opportunities with GMF. This sustained engagement strengthens long-term connections across the think tank and civil society sectors of Central and Eastern Europe, fostering a more vibrant and cohesive policy exchange among the next generation of the region's experts.



Skill-building via trainings

The fellowship provides fellows with opportunities to enhance their abilities in analysis, policy writing, communication, outreach, and advocacy. The skills gained through trainings help fellows strengthen their professional profile and provide them with valuable tools for continued development beyond the fellowship.

Financial support

A stipend and a travel and research budget provide fellows the means to conduct fieldwork, to network with stakeholders, and to dedicate the necessary time to deliver a quality policy paper by the end of their fellowship.



ReThink.CEE Policy Papers and Analyses

By the end of their fellowship,
ReThink.CEE fellows produce an
English-language policy paper
addressing a key challenge facing
Central and Eastern Europe.
Throughout the fellowship, they
receive ongoing writing and
editorial support from a senior
English-speaking editor, ensuring
their work meets professional
publication standards. The
opportunity to develop a policy
paper allows fellows to apply their
newly acquired skills and strengthen
their analytical portfolio.

To facilitate dissemination. ReThink.CEE fellows have the opportunity to present their findings in online debates with key figures in the policy community, which amplifies their voices and integrates their insights into international policy debates. GMF further supports the spread of ideas through its extensive outreach channels, including its mailing lists and social media platforms. These enhance fellows' visibility at the international, regional, and national levels, embedding them within relevant policy communities. In parallel, ReThink.CEE discussions and briefings reinforce the fellowship broader goal to elevate new regional perspectives and to position fellows as active and influential contributors to policy debates.
