






George Melashvili is a public figure and a civic activist who is the founder and president of the Europe-Georgia Institute, a hybrid non-governmental organization in Georgia. Melashvili serves as an invited lecturer of International relations theory at the Free University of Tbilisi and East Asian studies at the University of Georgia. Melashvili graduated from the Free University of Tbilisi in 2016 with a degree in International Relations. During his bachelor studies, he received a scholarship from the Academy of Korean Studies to study South Korea's economic development and democratic transition. He is also an alumnus of Haifa University program supported by the government of Israel and successfully graduated from Swedish Institute Summer Academy Young

Professionals (SAYP) in Malmö, Sweden.

During the 2016 Georgian parliamentary election, George Melashvili managed the unprecedented Get out the vote campaign "Your Voice, Our Future" uniting citizens of Georgia to realize the importance of their vote and increase voter turnout. The campaign mobilized 500 volunteers from Georgia's all regions and was held in Georgia's all 11 regions and the capital city and managed to increase the youth turnout by more than 20%. The campaign was followed by an #Initiative project aiming to increase youth participation in decision making and civic life and issued more 500 small scale grants were issued to support activities in more than 20 municipalities of Georgia.






